

3. <u>HAZARDS IDENTIFICATION</u>

EMERGENCY OVERVIEW:

CAUTION! Harmful if swallowed. Avoid inhaling fumes or spray. Avoid contact with skin, eyes, or clothing.

Do not contaminate water bodies.

POTENTIAL HEALTH EFFECTS

ROUTE(S) OF ENTRY: Inhalation, ingestion, skin and eye contact.

SIGNS OF ACUTE OVEREXPOSURE: Nausea, headaches, eye irritation. The presence of petroleum distillates may lead to central nervous system (CNS) depression, drying of the skin, dermatitis. Aspiration (breathing) of vomitus after swallowing may lead to aspiration pneumonitis.

SIGNS OF CHRONIC OVEREXPOSURE: Same as acute overexposure.

- **CARCINOGENICITY:** EPA lists 2,4-D acid, an impurity in 2,4-D Isopropyl Ester, as being in category D, not classifiable as a Human Carcinogen. IARC lists 2,4-D acid as being in category 2B. Care should be taken when handling this product.
- **MEDICAL CONDITIONS AGGRAVATED BY EXPOSURE:** Preexisting neurological problems may be aggravated by exposure to this product. Near fatal exposures may result in congestive effects to a wide variety of organs based on the presence of petroleum distillates.

4. **FIRST AID MEASURES**

- **EYES:** Immediately flush the eyes with copious amounts of clear, cool running water for a minimum of 15 minutes. Hold the eyelids apart during the flushing to ensure rinsing of the entire surface of the eyes and lids with water. Contact a physician immediately. If there will be a delay in getting medical attention, rinse the eyes for at least another 15 minutes.
- **INHALATION:** Remove victim to fresh air. If breathing has ceased, clear the victim's airway and start mouth-to-mouth artificial respiration. If breathing is difficult, give oxygen. Contact a physician immediately.
- **INGESTION:** Immediately dilute the swallowed product by giving large quantities of water, but do not induce vomiting. If vomiting occurs, give fluids again. Have a physician determine if condition of patient will permit induction of vomiting or evacuation of stomach. Never give anything by mouth to an unconscious person. Contact a physician immediately.

4. FIRST AID MEASURES, cont'd

- **SKIN:** Immediately flush all affected areas with large amounts of clear water for at least 15 minutes. Remove contaminated clothing. Do not attempt to neutralize with chemical agents. Wash clothing before reuse. If skin irritation develops, contact a physician immediately.
- **NOTE TO PHYSICIANS:** This product contains petroleum distillates. Gastric lavage should be considered following intubation with a cuffed endotracheal tube to prevent aspiration of vomitus. Contact your local or state poison control center for further information.

- HAZARDOUS COMBUSTION PRODUCTS: This product emits hazardous fumes of unknown composition when burned.
- **EXTINGUISHING MEDIA:** Foam, carbon dioxide, dry chemical, water fog DO NOT USE WATER STREAM.
- **FIRE FIGHTING INSTRUCTIONS:** Do not breathe fumes. Wear complete fire fighting gear, including protective gloves, eye protection, and self-contained breathing apparatus. Wash clothing before reuse.

6. <u>ACCIDENTAL RELEASE MEASURES</u>

- **GENERAL:** Use adequate ventilation and personal protective equipment suitable for the circumstances (See Section 8). Keep bystanders upwind and away from the spill. Turn off all ignition sources and use sparkproof equipment to prevent accidental ignition of the solvent.
- **SMALL SPILL:** Cover with absorbent (clay, sawdust, straw, kitty litter, etc.), to absorb the liquid. Sweep or vacuum and place into an open drum. Clean the area with common powdered household detergent and a stiff brush and just enough water to make a slurry. Absorb and sweep into the same open drum. Rinse with water, absorb, and add to the waste drum. Close the drum and dispose of properly.

6. ACCIDENTAL RELEASE MEASURES, cont'd

LARGE SPILL: Dike the spill to prevent contamination of local water sources. Siphon the majority of the liquid into drums for use or disposal, depending on the circumstances. Clean the area as described for a small spill.

7. HANDLING AND STORAGE

- **HANDLING:** Wear recommended personal protective equipment (PPE)(See Section 8). Avoid breathing fumes or spray. Avoid contact with skin, eyes, or clothing. Wash PPE after each day of use and before reuse. Wash hands and face thoroughly after use.
- **STORAGE:** Store product in original container in a secure, dry and temperate area. Do not freeze. Do not use, pour, spill or store product near heat or open flame. Keep container closed when not in use. Do not store near food, feed, fertilizers, seeds, insecticides or fungicides. Do not use or store around the home. Avoid contact with water. Keep away from children and pets.

8. <u>EXPOSURE CONTROLS/PERSONAL PROTECTION</u>

- **ENGINEERING CONTROLS:** Ventilation should be provided that is sufficient to keep exposure to this product below the TLV's.
- **RESPIRATORY PROTECTION:** A properly <u>FIT-TESTED</u> NIOSH/MSHA approved respirator fitted with organic vapor cartridges should be used when working with this product, if ventilation is insufficient to keep exposures below the TLV's.
- **SKIN PROTECTION:** Long-sleeved shirt and long pants, chemical-resistant gloves, shoes plus socks, are all required when working with this product. If there is a possibility of splashing or spillage, a chemical resistant apron or chemical resistant coverall should also be worn.
- **EYE PROTECTION:** Safety glasses must be worn when working with any chemical. If there is a possibility of splashing or spillage, safety goggles or a faceshield should also be worn.
