# 4. First-Aid Measures

#### **General advice:**

## **Cleanup:**

If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. After decontamination, spill area can be washed with water. Collect wash water for approved disposal.

# 7. Handling and Storage

# Handling

# General advice:
