Causes substantial but temporary eye injury. Harmful if absorbed through the skin. Do not get in eyes, on skin, or on clothing. Wear goggles or safety glasses. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove contaminated clothing and wash before re-use.

4. First aid measures:	
After inhalation:	Remove the person to a well ventilated area. Ensure the person is warm and comfortable. Call a poison control centre or doctor for treatment advice.
After skin contact:	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.
After eye contact:	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.
After swallowing:	Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person

Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. Store in dry, cool (below 32°C) conditions in original container. Use flammable liquid storage area. Keep containers tightly closed when not in use.
