K-90 is a water-soluble product providing an easily diluted surface active agent. It is for use with herbicides, defoliants, desiccants, insecticides and fungicides to increase surface wettability, spreadability, contact activity, and penetration.

SUGGESTIONS FOR USE

Usage of K-90 will vary with different sprays and with method of application and water hardness conditions. Use only minimum amount necessary to achieve a smooth uniform film.

A. Dilute full volume sprays:

1. Insecticides, fungicides-use between 2 oz. to 8 oz.

K-90 per 100 gallons of final spray mixture.

2. Herbicides, defoliants, desiccants - use between 1/2 pint to 8 pints K-90 per 100 gallons of final spray mixture.

B. Concentrate sprays - As sprays are concentrated to 2x, 10x, etc., the amount of K-90 should be increased in about the same proportion as the pesticide.

C. Aerial use - To improve pesticide coverage by air, use 1/2 to 2 pints K-90 in sufficient volume spray mix to cover.

K-90 should be added to the spray tank last with agitator running, after all other ingredients are well mixed.

K-90 spray adjuvant is compatible and safe to use with nonselective herbicides, such as MSMA, Dowpon, Dow General, Amino Triazole, Paraquat, etc., where a spray adjuvant is recommended to be used with such materials.
