2. HAZARDS IDENTIFICATION

Emergency Overview:

Appearance and Odor: Clear, light amber colored liquid with a slight amine odor.

Warning Statements: Keep out of reach of children. DANGER. Corrosive. Causes irreversible eye damage. Harmful if swallowed, inhaled or absorbed through skin. Do not get in eyes, on skin or clothing. Avoid inhalation of spray mists.

Potential Health Effects:

Likely Routes of Exposure: Inhalation, eye and skin contact

Eye Contact: Severely irritating.

Skin Contact: Slightly irritating. Overexposure by skin absorption may cause headache, dizziness, names were approximately irritation, weekness and central narrous system depression.

4. FIRST AID MEASURES

If in Eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If Swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If on Skin: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

If Inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

5. FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Wear appropriate protective gear for the situation. See Personal Protection information in Section 8.

Environmental Precautions: Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.

Methods for Containment: Dike spill using absorbent or impervious materials such as earth, sand or clay. Collect and contain contaminated absorbent and dike material for disposal.

Methods for Cleanup and Disposal: Pump any free liquid into an appropriate closed container. Collect washings for disposal. Decontaminate tools and equipment following cleanup. See Section 13: DISPOSAL CONSIDERATIONS for more information.

Other Information: Large spills may be reportable to the National Response Center (800-424-8802) and to state and/or local agencies.

7. HANDLING AND STORAGE

Handling:

Do not get in eyes, on skin or clothing. Avoid inhalation of spray mists. Users should wash hands before eating, drinking, chewing gum, using tobacco or using toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.

Storage:

Always use original container to store pesticides in a secured warehouse or storage building. Do not store near open containers of fertilizer, seed or other pesticide. Store at temperature above 32°F. If allowed to freeze, warm to at least 40°F and remix before using. Freezing does not alter this product. Containers should be opened in well-ventilated areas. Keep container tightly sealed when not in use. Do not stack cardboard cases more than two pallets high. Do not contaminate water, food or feed by storage or disposal.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

Engineering Controls:

Where engineering controls are indicated by specific use conditions or a potential for excessive exposure, use local exhaust ventilation at the point of generation.

Personal Protective Equipment:

Eye/Face Protection: To avoid contact with eyes, wear face shield, goggles or safety glasses with front, brow and temple protection. An emergency eyewash or water supply should be readily accessible to the work area.

Skin Protection: To avoid contact with skin, wear long pants, long-sleeved shirt, socks, shoes and waterproof gloves. An emergency shower or water supply should be readily accessible to the work area. **Respiratory Protection:** Not normally required. 10. STABILITY AND REACTIVITY

Chemical Stability: This material is stable under normal handling and storage conditions.

Conditions to Avoid: Excessive heat. Do not store near heat or flame. **Incompatible Materials:** Strong oxidizing agents: bases and acids.

Skin Sensitization: Not a contact sensitizer in guinea pigs following repeated skin exposure.

Subchronic (Target Organ) Effects: Repeated overexposure to phenoxy herbicides may cause effects to liver, kidneys, blood chemistry, and gross motor function. Rare cases of peripheral nerve damage have been reported, but extensive animal studies have failed to substantiate these observations, even at high doses for prolonged periods.

Carcinogenicity / Chronic Health Effects: The International Agency for Research on Cancer (IARC) lists exposure to chlorophenoxy herbicides as a class 2B carcinogen, the category for limited evidence for carcinogenicity in humans. However, newer rat and mouse lifetime feeding studies did not show carcinogenic potential for MCPA.

Reproductive Toxicity: MCPA studies in laboratory animals have shown testicular effects and lower male fertility.

Developmental Toxicity: MCPA studies in laboratory animals have shown decreased fetal body weights and delayed development in the offspring at doses toxic to mother animals.

Genotoxicity: There have been some positive and some negative studies, but the weight of evidence is that MCPA is not mutagenic.

Environmental Fate:

MCPA DMA rapidly dissociates to parent MCPA in the environment. In soil, MCPA is microbially degraded with a typical half-life of approximately 10 to 14 days.

13. DISPOSAL CONSIDERATIONS

Waste Disposal Method:
