Fire Fighting Guidance

Keep personnel removed and upwind of fire. Wear self-contained breathing apparatus. Use water spray. Cool tank/container with water spray. If area is heavily exposed to fire and if conditions permit, let fire burn itself out since water will increase contamination hazard.

6. ACCIDENTAL RELEASE MEASURES

In Case of Spills or Leaks

Keep unnecessary people away and isolate hazard area. Wear appropriate personal protective equipment described in Section 8. If spilled material is a liquid, prevent from entering sewers, waterways or low areas. Use an absorbent to absorb material, then shovel or sweep up and place into a clean container for disposal.

Hexythiazox

This pesticide is toxic to fish and aquatic invertebrates. Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Drift and runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when cleaning equipment or when disposing of equipment washwaters.
