GENERAL INFORMATION

CROP OIL CONCENTRATE CA™ is a nonionic blend of surfactants and highly refined phytobland paraffin oil. It is designed for use with a broad range of pesticides where an oil concentrate adjuvant is recommended. **CROP OIL CONCENTRATE CA™** increases contact activity and penetration of the spray while also providing uniform coverage on leaf surfaces. Always follow herbicide label recommendations.

FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes; then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center for treatment advice.

RECOMMENDED RATES

Ground, Aerial, Low volume, CDA: Use 4-8 pints per 100 gallons water or .50-1.00% v/v concentration. With Atrazine and Aatrex, use 1 quart to the acre with desirable amount of water.

MIXING

To prepare for pesticide application fill spray tank one-half full with water and begin agitation. Add pesticide or fertilizer as recommended and then add **CROP OIL CONCENTRATE CA™** while continuing agitation. Continue to agitate until tank is full and agitate before and during each application.

NOTE: The effect of any adjuvant on a chemicals performance is not predictable under all conditions of weather, plant vigor, application methods and even water types. The user should consult his local agricultural extension agent or make his own tests to determine the optimum level of **CROP OIL CONCENTRATE CA™** for special pesticide spray and crop.

CONTAINER DISPOSAL
