### Section 1. FIRST AID

**IF SWALLOWED:** Call a physician or Poison Control Center immediately for treatment advice. Drink 1-2 glasses of water. DO NOT induce vomiting unless told to do so by a physician or Poison Control Center. If vomiting does occur, give water again. Do not give anything by mouth to an unconscious person.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Get medical attention if irritation persists.

**IF INHALED:** If adverse symptoms are experienced, move to fresh air. If breathing becomes difficult, see a physician.

## Section 2. PERSONAL PROTECTIVE EQUIPMENT (PPE)

**Skin Protection:** Long-sleeved shirt and long pants, chemical resistant gloves made of any waterproof material and shoes plus socks.

## Section 3. POTENTIAL HEALTH EFFECTS

**Eyes:** Mild irritant, may cause redness and burning.  
**Skin:** Mild irritant, especially from prolonged exposure. May cause redness and/or chaffing.  
**Ingestion:** May cause excessive salivation, vomiting, nausea, acetoneuria (odor of acetone on breath), convulsions, increased body temperature, depression of medullary respiratory and vasomotor control centers. May result in coma and can be fatal. **Note:** Because of the low amounts of metaldehyde in the product, it is unlikely the victim can be exposed to sufficient quantities of metaldehyde to have coma or death induced.  
**Inhalation:** Inhalation of dust may cause mild irritation of nasal mucous membranes. May cause dry coughing or wheezing.

## Section 6. STORAGE AND HANDLING

<b>Storage:</b>	Store in original container in a cool dry location away from direct sunlight. Keep container tightly closed. Store away from children and domestic animals.
