SECTION 4 - FIRST AID MEASURES

First Aid responders should use protective equipment in Section 8 if there is a potential for exposure to product.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

FIRE AND EXPLOSION HAZARD: Can burn in fire, releasing irritating and toxic gases due to thermal decomposition or combustion.

FIRE FIGHTING INSTRUCTIONS: Evacuate area and fight fire upwind from a safe distance to avoid hazardous vapors and decomposition products. Product is packaged in water-soluble pouches. Do not allow pouches to become wet prior to adding to the spray tank. Do not handle the pouches with wet hands or wet gloves. Always reseal overwrap bag to protect remaining unused pouches. Do not remove water-soluble pouches from overwrap except to add directly to the spray tank.

STORAGE: Store in a cool dry area above freezing. The water-soluble pouch may become brittle at storage temperatures below 32°F, but the fungicide is not affected. Do not remove the water-soluble pouches from the container except for immediate use.

TERATOGENICITY: Myclobutanil exhibited some reproductive toxicity in long term rat and rabbit studies at doses toxic to maternal.

MUTAGENICITY: In-vitro and animal evidence indicates that myclobutanil is non-mutagenic

ENVIRONMENTAL SUMMARY: Do not apply directly to water or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters. Do not apply when weather conditions favor drift or runoff from areas treated.
