## 4. First-Aid Measures

### General advice:

### Protective equipment for fire-fighting:

### 6. Accidental release measures

### **Personal precautions:**

Take appropriate protective measures. Clear area. Shut off source of leak only under safe conditions. Extinguish sources of ignition nearby and downwind. Ensure adequate ventilation. Wear suitable personal protective clothing and equipment.

### **Environmental precautions:**

Do not discharge into the subsoil/soil. Do not discharge into drains/surface waters/groundwater. Contain contaminated water/firefighting water.

### Cleanup:

Dike spillage. Pick up with suitable absorbent material. Place into suitable containers for reuse or disposal in a licensed facility. ## 7. Handling and Storage

### Handling
