VI. HEALTH HAZARD DATA

ROUTES OF ENTRY: INHALATION, CONTACT, INGESTION.

INHALATION: MAY CAUSE IRRITATION OF NAZAL PASSAGES. INHALATION OF HIGH CONCENTRATIONS MAY CAUSE HEADACHES, DIZZINESS, DROWSINESS, ANESTHESIA, AND UNCONSCIOUSNESS.

SKIN CONTACT: FREQUENT OR PROLONGED CONTACT MAY CAUSE IRRITATION. THE ACUTE DERMAL LD₅₀ IN RABBITS HAS BEEN SHOWN TO BE > 2,000 MG/KG.

EYE CONTACT: CAUSES IRRITATION TO THE EYES.

INGESTION: THE MATERIAL IS CONSIDERED TO BE ONLY SLIGHTLY TOXIC. THE ORAL LD₅₀ HAS BEEN CALCULATED TO BE 3299 MG/KG.

CARCINOGENICITY: THIS PRODUCT CONTAINS *NAPHTHALENE* WHICH THE INTERNATIONAL AGENCY FOR RESEARCH ON CANCER (IARC) HAS CLASSIFIED AS A POSSIBLE HUMAN CARCINOGEN (GROUP 2B). *TRIFLURALIN* IS AN EPA CLASS C CARCINOGEN. *TRIFLURALIN* IS NOT LISTED AS A CARCINOGEN BY IARC, NTP, OSHA, OR ACGIH.

MEDICAL CONDITIONS POSSIBLY AGGRAVATED BY EXPOSURE: SKIN IRRITATION MAY BE AGGRAVATED IN PERSONS WITH EXISTING SKIN LESIONS. BREATHING OF VAPORS MAY AGGRAVATE EXISTING CONDITIONS SUCH AS ASTHMA, EMPHYSEMA, OR CHRONIC BRONCHITIS.
